Will Sipsey, the Chair, called the TAC meeting to order at 6:30PM

Approval of May 16th, 2018 TAC Meeting Minutes

**Steve Huffaker motions to approve the minutes of the May 16, 2018 meeting of the TAC, seconded by Karen Shackett. Upon no further discussion, the minutes of the May 16, 2018 meeting of the TAC were unanimously approved, with Tom Scanlon abstaining.

$\underline{VT\ Long\text{-}Range\ Transportation\ Plan\ 2^{nd}\ Public\ Hearing}-Dave\ Pelletier,\ VTrans$

As part of statewide outreach associated with the updated of the Vermont Long Range Transportation Plan, Dave Pelletier, Planning Coordinator with VTrans, provided a PowerPoint presentation on the current draft of the Plan. Dave visited all Vermont RPCs during summer 2017 to conduct the first round of public meetings and is now visiting all RPCs during summer 2018 to conduct the second round of public meetings. In general, the Secretary of the Agency has directed Dave and VTrans staff to create a Plan that is as lean, succinct, and approachable as possible.

Questions/Comments that arose from the presentation:

- Tom Scanlon noted that the Plan clearly addresses air, rail, and roads does the Plan also address water, and specifically Lake Champlain ferries?
 - Not addressed directly because they are privately owned; acknowledges that rail
 is also privately owned, however VTrans directs a significant amount of resources
 to rail and rail infrastructure
 - It was also noted that there is an outside perception that the ferries are stateowned entities, regardless of their privately-owned status
- Regarding ferries, Karen Shackett noted that no public bathrooms exist at the ferry locations, which is important as these are entry/exit locations to/from Vermont; noted that adjacent landowner at Shoreham ferry location has issues with people going to bathroom on private property
- Noted that GPS accuracy also remains an important issue for many Addison County towns, as trucks are still be sent out routes that they should not be traveling on
- Karen also shared the idea of potentially utilizing existing, state-owned space along and between highways for bicycle-pedestrian paths as is done in other places like Colorado
- Dave noted that there is a new transportation project prioritization system in development
- VTrans' approach to asset management moving forward: "right investment, right asset, right time"
