 2. Front of Book – 4 projects – Addison, Cornwall, Middlebury, Ripton. Norm moved that the projects be prioritized as 1-Addison, 2-Cornwall, 3-Ripton, and 4-Middlebury; Jeff seconded. All approved in a roll call vote.
 - Town bridge – 2 projects – Leicester (FofBk) & Salisbury/Cornwall (D&E). Karen moved and Norm seconded to accept the two projects as prioritized by VTrans. All approved in a roll call vote.
