- Transportation Updates from Mike
 - Status of TAC Grants –
 - Lincoln – the S. Lincoln Rd. realignment study is near completion and the consultants are expected to present the results at the next TAC meeting
 - Bristol – a virtual local concerns meeting pedestrian access study was held last week and the project is progressing

- Salisbury – the intersection study went out to bid and received five proposals. Following a review by ACRPC and town officials, the work was offered to Dubois and King.
 - Construction Projects – Middlebury, Bristol, Vergennes – these three projects have resumed.
 - Grants in Aid status update – new deadline October 15
- Business/Roundtable
 - Cornwall, Brian – the town is not satisfied with VTrans response to their concerns about the VT125 knoll. Vtrans has scheduled a safety review and the addition of rumble strips.
 - Addison, Jeff – He has noticed more truck traffic along VT17 with the beginning of the Vergennes paving project.
