# **ACRPC Staff Updates**



## Kevin Behm, Assistant Director & GIS Data Manager

In preparation for the office closure I have worked with the other staff to make sure they have the capability to work remotely from home. Sometimes this involved using different programs for different computer set-ups. In addition, not all of the staff were familiar with the Zoom program which allowed off-site meetings. At this point, the entire office has been functioning successfully from their homes. Pauline is currently calling-in on our conference line, but next week she will be able to receive emails as well. I have been communicating with the members of the Natural Resource Committee and today's meeting before this Commission meeting was not held since a water quality discussion is on the agenda. The Addison County River Watch Collaborative has also be instructed on using hosting remote meetings. Municipal mapping is continuing with zoning work for New Haven and Village Designation in Shoreham. If large format paper maps are needed, I will be scheduling time to print them as a group to limit my in-office time. Benton and I have also been completing the culvert uploads, including photos, to the state's website.

### Mike Winslow, Transportation Planner

Transportation planning efforts at ACRPC continue during the office shutdown. Meetings have been transitioned to on-line venues including TAC, elderly and disabled transit, and meetings around TAC funded studies. The TAC was able to complete project prioritization during an on-line meeting in March. At the April meeting they will be hearing a presentation from Chittenden County Regional Planning about planning efforts around the I-89 corridor and any impacts such efforts might have on Addison County. We are working with consultants to develop on-line tools to gather public input for on-going projects including the tri-town bike loop and pedestrian access design studies in Bristol and Lincoln. A reminder to all towns that your annual Municipal Road General Permit compliance forms were due April 1. Contact Mike Winslow (<u>Mwinslow@acrpc.org</u>) if you have questions. Planning continues for the statewide Walk Bike Summit set to take place in Middlebury, but the event has been postponed until October 16 in the hopes that life will be more normal by then.

#### **Emergency Management Planner**

The COVID-19 outbreak has been a priority for all of us this month and will continue to be. I've been providing information to town municipal officials and Emergency Management Directors (EMDs) about the continuing COVID-19 outbreak, as well as regularly scheduled Local **Emergency Management Plans and other tools** to coordinate this response and think ahead to future ones. Our ACRPC COVID-19 webpage (http://acrpc.org/programs-services/emergencymanagement/coronavirus-covid-19/) is being updated with relevant information, including links to the VT Department of Health and all the fantastic efforts being organized by local municipalities, emergency responders, and volunteer citizens. I and others here are taking part in multiple conference calls with state officials, fire departments, and local officials each week to stay up-to-date on changing resources, needs, and policies. The Local Emergency Planning Committee is running run public health notices and supporting Porter Hospital in the Addison Independent. Reach out to me if you have needs!

## Katie Raycroft Meyer Community Planner

Throughout February and into the beginning of March, I completed final reviews of Town and Enhanced Energy Plans for Weybridge and Salisbury. Both communities did an excellent job at formulating and integrating these plans and were on track for regional approval. The Weybridge plan was regionally approved March 11 but the Salisbury public hearing for April 6 had to be postponed. In early March the communities of Vergennes and Monkton also submitted updated town plans and enhanced energy plans for review and regional approval. As we (the staff) become more proficient with video conferencing, specifically for public hearings, we will have a better sense as to how and when to schedule these meetings.

A priority for me during this time is to complete a draft of the updated Regional Population and Housing Plan. Over the last year, I have worked closely with the ACRPC Housing Committee to develop a clear set of Goals and Policies that address existing housing issues and support municipalities' work towards developing solutions in their communities. The committee's goal is to have a final draft by June.

### ECO Americorps Water Quality Planner

Water Quality efforts at the ACRPC have continued and I continue to serve from home. The Addison County Riverwatch Collaborative is working with the RPC to reorganize and restructure their sampling season while maintaining a responsible social distance. They are also going to take this lapse in regular programing to reorganize their section of the RPC webpage. Kevin and I are formatting and uploading Culvert Inventory data collected with Fulcrum to the state's database, VTCulverts. Outside of my water quality responsibilities I am creating a request for proposals template which could be used by any Addison County municipality or school district to solicit proposals for a Community Solar Array. I am also reaching out to various aid organizations such as Meals on Wheels in order to directly serve those in need during this difficult time.

**VTrans Structures and Class 2 Roadway Grants** The deadline for application for VTrans Structures and Class 2 Roadway Grants has been extended to May 15

#### **VTrans Projects**

The Agency of Transportation (VTrans) has determined that with the exception of one emergency project, all construction projects it provides funding for do not meet the criteria for being critical for public health, safety or national security that would qualify them as essential per Governor Scott's Executive Stay Home Stay Safe Order issued March 24<sup>th</sup>. This pertains to any construction project that VTrans is providing funding for, including grant projects. This determination also extends to VTrans' maintenance activities which are currently limited to winter snow and ice control, safety patrols and responding to necessary repairs that affect the safety of the traveling public. VTrans urges municipalities to consider using VTrans' direction on projects they are funding as guidance for interpreting what are essential services per Governor Scott's Executive Order.
