

Meeting of Addison County providers who work with adolescents and their families Date: Monday, December 10, 8:30–10am Location: Counseling Service of Addison County, 109 Catamount Park, Middlebury

This meeting is hosted by the Local Interagency Team (LIT) and started after a review of the most recent Youth Risk Behavior Survey data and a discussion about the needs of adolescents and how we work together to support youth. One of the things we noticed was that we have a gap in the integration of services for youth- we don't all know each other as well as we would like to and there is awareness that we may want to build more consistent approaches and a more shared sense of best practices on topics like LGBTQ support, substance use, self-harming behavior, and transitions to adulthood (and many more!).

The agenda of this initial meeting will focus on how we could work together, a better definition of what might be areas of interest and a decision about whether we would like to meet more regularly together and what that would look like.

Five Star and Urban Waters Restoration Grant Program

The Five Star and Urban Waters Restoration grant program seeks to develop community capacity to sustain local natural resources for future generations by providing modest financial assistance to diverse local partnerships focused on improving water quality, watersheds and the species and habitats they support. Potential projects include a variety of ecological improvements along with targeted community outreach, education and stewardship.

Projects should also increase access to the benefits of nature, reduce the impact of environmental hazards and engage local communities, particularly underserved communities, in project planning, outreach and implementation.

This program expects that applicants will represent a mixture of urban and rural communities. NFWF may use a mix of public and private funding sources to support any grant made through this program.

Rural Fire Protection Grant Program

Application deadlines: February 1st, April 1st, June 1st, and August 1st, 2019.

The Vermont Rural Fire Protection Task Force is pleased to announce the 22nd year of funding for towns to improve fire suppression capabilities. The goals of the program are to:

- Save lives, by reducing response time and improving both public and firefighter safety.
- Enable fire fighters to have quicker, easier, and safer year-round drafting capability.
- Reduce risks to property and natural resources, both public and private.
- Lower insurance premiums, both public and private

The installation of **new** dry hydrants & other types of rural water supplies is still the priority of the program, but eligible projects also include repair/upgrade, replacement, relocation of existing rural water supplies, and new "drafting site" development, (including access development, stepping stones for portables, etc.). The maximum grant award is \$5,000 per project or system; a 25% local match is required.

ICS 100 - Introduction to Incident Command

Time: 6:30 -10:30 PM (1830-2230) **Dates:** 12/6/2018 and 12/13/2018

Location: Middlebury Fire Department, 5 Seymour St, Middlebury VT 05753

This course provides training and resources for personnel who require a basic understanding of the Incident Command System (ICS).. The course describes the history, features and principles, and organizational structure of the Incident Command System. It also explains the relationship between ICS and the National Incident Management System (NIMS). This course is for entry-level first responders (firefighters, police officers, emergency medical services providers, public works, public health personnel, others) and other personnel that require introductory ICS.
