

State Designated Areas Workshops

On **March 13**th, the Addison County Regional Planning Commission (ACRPC) and the Department of Housing and Community Development (DHCD) will be hosting two presentations on some of the benefits associated with State designated areas, like village centers, designated downtowns and new neighborhood development areas.

First, at 4:00 p.m. ACRPC and DHCD will conduct a more intensive workshop on Neighborhood Development Designation Areas, how to form them and the benefits associated with them. ACRPC encourages representatives of communities with water and/or wastewater infrastructure to attend this workshop since those communities already have most or all the resources to meet the designation requirements. Permitting benefits for new housing and mixed used development projects are available within the Neighborhood Development Area.

Second, as part of ACRPC's March Full Commission meeting at 7:00 p.m. ACRPC and DHCD will conduct a more generalized workshop on the state designation programs and the benefits of each.

Both programs are open to the public and will take place at the office of ACRPC at 14 seminary Street in Middlebury. We hope that representatives of your communities will be able to join us for one or both of the workshops. We will send out more information regarding both workshops as the date grows closer.

Vergennes Truck Study Results Release

There will be a public meeting on **Tuesday**, **April 2**, **2019** at the Vergennes Opera House to review and discuss the draft final report on strategies to minimize the damage from truck traffic on Vergennes downtown. The meeting will start at 6PM with an informal opportunity to talk with the consultants, review the three options, and have personal questions addressed. A formal presentation will begin at 7PM followed by public comments.

The study considers three alternatives for alleviating the impacts of truck traffic: in-line changes to the existing 22A, construction of a by-pass around Vergennes, and use of Rt. 17 as an alternative truck route. The study considers benefits and costs of each alternative.

The report is being prepared by the consulting firm Stantec with funding provided by the Addison County Regional Planning Commission (ACRPC) and the Vermont Department of Transportation. The April 3 meeting follows a preliminary scoping meeting that took place in Vergennes on September 26, 2018.

The draft report will be available on the ACRPC website (http://acrpc.org/programs-services/transportation/transportation-projects/) in mid-February.

Vermont Housing and Conservation Coalition (VHCC) Legislative Day

Tuesday, February 19, 2019

A day for housing and conservation supporters to champion the projects and values supported by Vermont Housing and Conservation Board (VHCB) funding. Legislators need to hear from Vermonters doing the work on the ground about how VHCB-funded projects are helping solve some of Vermont's most pressing issues. Please join them at the State House on Tuesday, February 19 to deliver the message that it is important to continue funding VHCB.

Northern Border Regional Commission Funding Workshop

At the beginning of this year the Federal government expanded the jurisdiction of the Northern Border Regional Commission (NBRC) to include the entire State of Vermont (Previously, it served only the counties in the northern 1/3rd of the State). The mission of the NBRC is to catalyze regional, collaborative, and transformative community economic development approaches that alleviate economic distress and position the region for economic growth.

On February 21, 2019, the Addison County Economic Development Corporation and the Addison County Regional Planning Commission will host a workshop designed to explain the function of the NBRC and to prepare applicants for grant funding to submit competitive applications for funding within the coming year (Letters of intent to apply are due March 31st.) The meeting will be held at the office of the Addison County Economic Development Corporation at 1590 Route 7 S, #8 Middlebury, Vermont at 10:00 a.m.

This meeting is designed to help non-profits and municipalities (prospective applicants) with the application process. Tim Tierney, Director of Business Recruitment and International Trade at the Department of Economic Development will discuss the purpose of the NBRC, and the funding available to municipalities, non-profits and trade organizations. Mr. Tierney will answer questions regarding the application process and types of projects that have received funding recently. More specifically, he will review the grant scoring criteria, match requirements and timelines.

The target audience for this workshop consists of major not-for-profit organizations serving the Region, Municipalities with infrastructure projects on the docket (wastewater, water, broadband), Recreational or tourist areas, and trade organizations. Grants & Funding

Downtown Transportation Fund Grants

Applications due March 11, 2019 and awards will be made in late April.

The Downtown Transportation Fund (DTF) supports revitalization efforts in designated downtowns each year. In Addison County these include Bristol, Middlebury, and Vergennes. The DTF has available approximately \$525,000 to help municipalities make a variety of transportation-related capital improvements (within or serving the downtown district and supporting economic development). The maximum annual grant is \$100,000, and a 50% match is required. Projects may include, but are not limited to, streetscape improvements, parking facilities, bike and pedestrian paths, rail or bus facilities, utility relocation, way-finding signage, street lighting, and ADA access improvements. Funds may not be used for costs incurred prior to the grant award or general operating and maintenance costs such as repaving.

Clean Water Initiative Funding

This year the Downtown Transportation Fund (DTF) has an additional \$100,000 in funding from the Agency of Natural Resources, Clean Water Initiative (CWI). DTF projects may apply for up to \$100,000 of "add on" clean water funding for eligible storm water implementation projects. A 50% match is required for these funds. Examples of eligible projects can be found on the Department of Environmental Conservation Green Stormwater Infrastructure (GSI) web page. The Vermont Green Streets Guide is a resource to help you plan, design and maintain your clean water project. The Clean Water Initiative will provide additional funds for DTF projects to implement stormwater management practices that help control flooding, reduce erosion, and improve water quality. The project must primarily mitigate nutrient or sediment pollution.

USDA Broadband ReConnect Program

Application deadlines in April - June 2019

This recently announced funding aims to bring high-speed internet e-connectivity to rural America. USDA has been investing in rural telecommunications infrastructure for decades, and our current programs offer more than \$700 million per year for modern broadband e-Connectivity in rural communities.

In the coming months, USDA will almost double these longstanding programs with at least \$600 million of additional funds for expanding rural broadband infrastructure in unserved rural areas and tribal lands.

Entities that are eligible to apply for assistance under the ReConnect Program include non-profit entities, for-profit corporations, limited liability companies, cooperative or mutual organizations, states, local governments, or any agency, subdivision, instrumentality, or political subdivision thereof, a territory or possession of the United States, and Indian tribes.

Award Funds may be used to pay for:

- To fund the construction or improvement of buildings, land, and other facilities that are required to provide broadband service.
- To fund reasonable pre-application expenses.
- To fund the acquisition and improvement of an existing system that is currently providing insufficient broadband service (eligible for 100 percent loan requests only).
- To fund terrestrial based facilities that support the provision of satellite broadband service.

Application deadlines February - April 2019

The Children's Literacy Foundation (CLiF) has several literacy grants currently available to public libraries, schools, and organizations serving low-income, at-risk, and rural children in Vermont and New Hampshire.

Grants currently available are:

- Revive Your Literacy Programming- for additional literacy programming completed in the 2018-2019 school year, open to any organization that has received a CLiF grant since 2014. Applications are due Feb. 1.
- Community Building- to build connections between kids and their communities through a Reading with Seniors program, a 1,000 Books Before Kindergarten challenge, a songwriting workshop, or the Young Writers' Project's My Community Story platform. The project must be completed in the 2018-2019 school year. Applications are due Feb. 6.
- Rural Libraries A school-year-long program awarded to public libraries in towns of 5,000 or less includes two storytelling sessions with professional authors/storytellers, new books for the public library and local elementary school library, mini grants for new library programming, and two new books for each child to choose. Applications are due April 2 for 2019-2020 school year.
