

The Municipal Planning Grant (MPG) program encourages and supports planning and revitalization for local municipalities in Vermont. Awarded annually and administered by the Department of Housing and Community Development, the MPG program works to strengthen Vermont by funding local planning initiatives that support statewide planning goals. Since 1998, the MPG program has provided over \$13 million to 235 cities and towns across Vermont to help plan for future growth and development, and improve the quality of life.

Municipalities with a locally adopted plan that is approved by the regional planning commission are eligible to apply. Applications are due at the beginning of October each year.



# Town Hall Theater Middlebury, Vermont May 8, 2020

The 2020 Vermont Walk Bike Summit Committee invites you to share your expertise and creative endeavors with your colleagues at our upcoming conference.



Sessions will be organized into the following tracks:

#### 1. Advocacy and Funding

This track offers participants a chance to learn more about how best to advocate for pedestrian and bicycle improvements and ways to get these funded.

#### 2. Built Environment

This track explores the role of community vision in developing an active transportation network, cost-effective measures to increase bicycle/pedestrian accommodations, and innovative designs that a community can implement to increase levels of biking and walking.

#### 3. Economic Development

This track highlights the financial benefits of walkable and bikeable communities.

#### 4. Safe and Healthy Communities

This track focuses on best practices for bicycle and pedestrian safety education and combining active transportation messaging with health promotion.

#### 5. Mobile Workshops

These workshops will include excursions outside the main conference venue to illustrate a particular design or planning concept by seeing it firsthand.

#### **Emerald Ash Borer Management Grants**

Grant applications due Friday, Jan 17, 2020

Vermont Urban and Community Forestry is seeking applicants for an Emerald Ash Borer Management grants program to support ash tree removals and tree replacements in municipalities impacted by an emerald ash borer (EAB) infestation.

VT UCF will award \$15,000 cost-share grants to three municipalities. This funding is intended for municipalities that are prepared to remove public ash trees threatened by EAB and to plant new trees of different species to offset the loss of the ash trees. Municipalities that are included within the <u>EAB Infested Area</u> (both Confirmed and High Risk Areas) as of Dec. 31st, 2019 may apply.

Municipal Incident Action Planning Hands-On Workshop

Incident Action Plans (IAPs) are a way to expand your Local Emergency Management Plan with more comprehensive incident annexes without spending a lot of time on unknowable situation-dependent details.

This hands-on workshop will begin with an overview of the municipal incident action planning process and introduction to simple, concise formats for developing and recording municipal IAPs. These are efficient, typically one page, tools for developing an operational framework for specific hazards such as a flood, ice storm, pandemic, HAZMAT spill, train derailment, etc.

The presentation will be followed by time to complete your own IAP with one-on-one assistance. Come prepared with your top priorities to plan for. Need some ideas? Check your Local Hazard Mitigation Plan!

Vermont's Community Right-To-Know Program and the Federal "Emergency Planning and Community Right-to-Know Act" (EPCRA) require that <u>all organizations, including local government facilities, annually report hazardous chemicals or pesticides</u> kept on site during the preceding calendar year (January 1 to December 31, 2019) by **March 1st.** 

The Vermont State Emergency Response Commission (SERC) requests that facilities submit Tier II reports using the EPA *Tier2Submit* software program.
