

Town of Orwell Receives Village Center Designation

The town of Orwell is the most recent community in Addison County to receive Village Center Designation from the Vermont Downtown Development Board. Orwell is an excellent example of a typical village green-centered community with many examples of 19th century architecture including the Victorian Gothic First National Bank. Buxton's Store, the hub of the community, is currently owned and operated by the original owner's grandson. The new proprietors are enthusiastic and active in reinventing the store to serve not only the older clientele but newer generations.

The Vermont Agency of Transportation is pleased to announce the 23rd year of funding to support the Vermont Better Roads Program. The goal of this grant program is to promote the use of Best Management Practices for erosion control and maintenance techniques along municipal roads that save money while protecting and enhancing Vermont's lakes and streams. To prioritize funding for projects that are providing significant water quality improvements this year applicants must indicate whether or not the projects that they intend to construct will be in full compliance with the MRGP. The Preservation Trust of Vermont has \$625,000 available for roof repair or replacement, structural repairs, window and door restoration, and fire safety improvements. Grants will be made in increments of \$50,000-\$100,000.


Emerald Ash Borer Management Grants

Vermont Urban and Community Forestry is currently seeking applicants for an Emerald Ash Borer Management grants program to support ash tree removals and tree replacements in municipalities impacted by an emerald ash borer (EAB) infestation.



VT UCF will award \$15,000 cost-share grants to three municipalities. This funding is intended for municipalities that are prepared to remove public ash trees threatened by EAB and to plant new trees of different species to offset the loss of the ash trees. Municipalities that are included within the <u>EAB Infested Area</u> (both Confirmed and High Risk Areas) as of Dec. 31st, 2019 may apply.

Public input on the TCI framework document at https://www.transportationandclimate.org/main-menu/ tci-regional-policy-design-stakeholder-input-form Since the beginning of this year, TCI jurisdictions have conducted public workshops and webinars regionally and in individual jurisdictions, including at ACRPC on September 18th. More than 1,000 people have participated in the public workshops and webinars, and more than 100 separate entries have been submitted through the TCI online public input portal, and people are encouraged to continue to submit input and ideas through early November. A draft memorandum of understanding (MOU) building on the framework is anticipated in Dec. 2019. After considering further public input, a final MOU is expected in the Spring of 2020, at which point each jurisdiction will decide whether to sign the final MOU and participate in the regional program.
