Electric Vehicle Supply Equipment (EVSE) Grant

Round 1 Deadline- Friday, November 30, 4:30 pm

Up to \$2.4 million in grants are available to install charging equipment at qualified locations within the State of Vermont. Governments (Federal, State, municipal, public education institutions, public utilities, and other public institutions), businesses, non-profits, homeowner associations, electric utilities, and EVSE equipment providers are eligible. Funding may be used for the purchase of Level 2 or direct current fast-charge (DCFC) equipment for light-duty vehicles, as well as supporting auxiliary costs, including: permitting, design, power connection, striping, on-site signage, warranty, software, internet connection, protective devices, and eligible installation costs.

Build It with KaBOOM! Playground Grants

KaBOOM! is a national nonprofit organization dedicated to saving play for America's children by creating great playspaces through the participation and leadership of individual communities. The organization is accepting applications for playground grants through Build It with KaBOOM!, a program that provides eligible communities with most of the funds, tools, and resources they need to build a custom-made playground in a single day. Through the program, selected community groups work closely with a KaBOOM! project manager who will lead activities as well as coordinate the equipment and material purchases for the project. Community members will take the lead in recruiting volunteers, securing food and tool donations, and completing any necessary site preparation.

Municipalities and nonprofits serving children of playground age are eligible to apply. Early submissions will get early consideration for 2019 opportunities and additional support.
