



#### **American Rescue Plan Funding**

The state has begun distributing Local Recovery Funds from the American Recovery Plan Act (ARPA) and Addison County municipalities should have their second portion of ARPA money by Labor Day.

Municipal and County funding can be used in several recovery categories, especially infrastructure. In addition, there is substantial **ARPA state funding being allocated through different agency programs** that may overlap or complement the projects your town wants to accomplish. Your town has **3 years to use the funds**, so **be patient and strategic!** 

Holding a public meeting to discuss community desires for strategically using this funding for transformative upgrades is strongly recommended. Your Town Plan is also a great place to find priority ideas.

If you are looking to spend a portion of your funding quickly, please **consider an investment in Maple Broadband and high-speed internet** for your community. National data indicates that Fiber-to-the-Premise networks drive economic development through job creation and retention, increased housing values (up to 3.1%¹) and documents a 4:1 rate of return on fiber broadband investments; every \$1 dollar invested in fiber broadband returns \$4 dollars to the local economy.

#### **Regional Housing Plan Completed**

The ACRPC is excited to share the 2021 draft update of the Regional Population and Housing plan. The plan summarizes and illustrates the changes, trends and characteristics of the region's population and housing stock over the last decade. The past year, however, was a challenging time to project what might occur in the future, specifically in the realms of population and housing. Inserted throughout the document are 'Covid-19' boxes that highlight unforeseen effects the pandemic has had on our community, such as increased in-migration, a steep rise in housing costs and rehabilitation projects completed with Coronavirus Aide, Relief, Economic Security (CARES) Act funding.

The plan's goals, objectives and implementation actions, crafted to support, advocate and guide the region's communities, are the result of a productive and collaborative work of the ACRPC's Housing Committee: Tim Davis, Tim Bouton, Tim Cook and Ellen Kurrelmeyer, along with ACRPC Community Planner, Katie Raycroft-Meyer. The staff at ACRPC would like to dedicate this plan to Ellen, who sadly passed away in April 2021.



### NBRC Grants go to Addison County Communities

The Northern Border Regional Commission (NBRC) invests in economic and infrastructure projects. In August 2021 they awarded grants to:

- Town of Middlebury —\$600,000 for the replacement of a critical water transmission main to provide reliable potable water supply and fire suppression to the Downtown business district.
- Town of New Haven \$350,000 for the relocation of the historic New Haven Rail Station from its current site to a location adjacent to the Town Office



Poor sight distances at the Lincoln Road/Route 116 intersection result in crashes and near-crashes. The Briggs Hill Road intersection with Lincoln Road can be dangerous and harrowing, particularly in winter conditions. And parking at Bartlett Falls along Lincoln Road, and sometimes in the road, creates hazardous conditions for motorists and visitors.

## Vermont Tier 2 & Tier 3 Rivers & Roads Training Program Tier 2 River and Roads workshops:

October 12th & 13th at VTrans Training Center (VTTC) at 1716 Route 302 in Berlin

Tier 2 is a two-day training and is both indoors and outdoor. Bring, or wear, appropriate field clothes and waterproof boots or old sneakers you can get wet! Each day will be indoors for slide shows and class exercises and river flume table demonstrations and outdoors on rivers and streams to observe in the field what we've seen and discussed indoors.

Open to all municipal staff, state staff, construction contractors, engineers, consultants, regional planning commission staff, conservation districts, and others working with communities on river and road related issues.

### <u>Tier 3 River & Roads- Advanced Flood Recovery & River Management Training Modules:</u>

At the VTrans Dill Building at 2178 Airport Rd, Berlin, Vermont

- November 3- Sediment & Wood Removal:
- December 1- Bridge & Culvert Replacement;

- February 17- Channel Stabilization;

Tier 1 and Tier 2 River and Roads trainings are a prerequisite to register for Tier 3.

Each training subject is a one-day class. There is no requirement to take them all and/or one topic prior to the other.


