3 Things Changes For Our New “Project Prioritization”

- Focus on Project Identification, not existing projects in the Capital Program
- **Asset Driven** Potential Projects vs. **Regionally Driven** Potential Projects.
- Not #1, #2, #3 but a Transportation Value Score up to 100.

Transportation Value

Mobility/Connectivity

- enhance or improve connectivity for bicyclists or pedestrians
- enhance or improve connectivity for transit users
- enhance or improve inter-modal connections

Regional

- Driving need for the project identified in a VTrans corridor, town, city, county, regional, or similar plan
- Municipality has been involved in planning study or has demonstrated support for the project in a similar way
- Project will improve the municipalities sense of community.
- There are key community facilities located with the limits of the project.

Health Access

- A transportation project enhances public health by increasing the opportunity for physical activity and increases access to destinations that improve health.
