- o Act 174 Updates The public service department has run into several issues in developing the updated regional LEAP models. However, we do have an updated generation scenarios tool to support the RPC in allocating how much distributed generation each of our towns is capable of and responsible for in the future. We also have updated energy maps at this time. Once all of the required materials have been provided, the committee will need to begin thinking about an update to the regional enhanced energy plan.
- o Solar workshop #2 the second workshop related to municipal solar development covered the use of the public Act 174 energy mapping tool. A <u>recording</u> of the workshop and <u>slide deck</u> are both available on the CVRPC <u>website</u>.
- o Energy score cards Ferrisburgh's energy scorecard was recently featured in the Addison Independent and has generated increased interest from community members. Maddi will be enlisting help from Zach, ACRPC's AmeriCorps member to develop an update to the scorecards once the LEAP model data is available.
