Description of Planning Study: A gas-tanker truck caught fire on U.S. 7 in Ferrisburgh on June 1, 2023, closing the route for traffic and leading to damage to the roadway and adjacent utility cable. Incidents like that have the potential to compromise transportation in the county, and the TAC believes it would be useful to have a better sense of the seriousness of that risk. This project proposes an assessment of the nature and extent of hazardous materials flowing through the county. The study could mimic procedures used by TRORC for a statewide <u>commodity flow study</u> between 2017 and 2019 and augment their findings.

Description of Planning Study:

This TAC grant would take 3-4 high-priority new project ideas identified in the public input and analysis portion of the 2023 Middlebury Bike-Ped Plan and add the level of engineering detail needed to make these projects grant-ready to apply for scoping, design and construction. Funds will be used for planning only. This TAC grant would enhance the bike-ped plan currently underway by adding back a reduction made to our scope of work. It would be co-funding a Municipal Planning Grant and municipal match totaling \$24,000. Our consultant indicated they could not include this element for that amount.

Expected Benefits of Planning Study:

This supplemental analysis would prepare us to apply to bike-ped grant programs as soon as 2024 pending match availability, e.g. VTrans Bike-Ped and TAP programs. Planning Consultant Services Pedestrian and Bicycle Connectivity Plan Town of Middlebury, VT May 5, 2023

Summary- The Town of Middlebury seeks qualified consultants to assist in the development of a Bicycle and Pedestrian Connectivity Plan that provides a vision for improving the safety, capacity and efficiency of the non-vehicular components of our transportation network.

With the help of a consultant, the Town will engage a broad spectrum of users and other stakeholders in a process for identifying needs and safety concerns, including gaps in the bike-ped network. The plan will provide transportation data and analysis to supplement the input collected. The plan will present an inventory of present and future projects as a detachable project matrix. Sidewalk/connectivity maps will be created showing existing conditions and future linkages. The Town and the Consultant will work together on developing recommendations for implementation. As the budget allows, this will involve developing concept plans and cost estimates for 3-5 selected projects.

The plan will have a Town-wide focus.

Background- The Middlebury 2020 Downtown Master Plan recommends a bike-ped plan and identifies connectivity needs in the Downtown area. The proposed project would implement that recommendation, while expanding our focus beyond Downtown's boundaries to contemplate connections with other existing and planned commercial/residential growth areas in Middlebury.

In a desire to advance affordable housing projects, the Town has performed master planning to visualize areas for infill development close to growth areas and served by water and sewer. Zoning map amendments have been made and an NDA designation was obtained that reflects our vision for future growth.

Work will begin this summer on Transit-oriented planning using a grant from CCRPC in partnership with ACRPC. The consultant for that project has not yet been selected. There are several opportunities for those planning efforts to complement one another.

Project Organization- The Town will organize a Steering Committee consisting of members of the Planning Commission as well as other interested stakeholders to provide support, guidance and oversight throughout the process. The Office of Planning & Zoning will provide Project Coordination, with Steering Committee meetings occurring as an agenda item at regular Planning Commission (PC) meetings. The Middlebury Infrastructure Committee and Director of Public Works Planning will be closely involved in the development of plan recommendations.

Project Partners- We have an active bike-ped advocacy community in Middlebury that will provide input and participation in this planning process. They support the Bike-Ped Plan because it will help to identify and vet some priority projects for funding. We will attend quarterly meetings of the Walk-Bike Council of Addison County to provide project updates and maintain their support for this project. Their membership includes Addison County Regional Planning, Local Motion, Safe Routes to Schools, VT Dept of Health, and covers several towns.

Other key stakeholders include Tri-Valley Transit, as well as employers like Porter Hospital, Middlebury College, and Addison County Supervisory Union. There will be multiple opportunities to collaborate with these organizations and partner on events such as Walk n' Roll events, the annual Bike Sale, our Animal Shelter's benefit walk, Downtown summer markets, etc. Our Planning Commission is willing to provide assistance performing in-person outreach.

Project Objectives-

The Objectives for this project are outlined below. The selected Consultant can discuss these objectives in greater detail with the Project Coordinator during the preparation of a proposal and contract.

Existing Conditions Analysis. Addison County Regional Planning will assist our consultant with compiling existing transportation data for the plan. Consultant will assess the condition and safety of existing bike-ped infrastructure, review crash data and collect information from Middlebury Police Department.

Project Management. Consultant will maintain regular contact with the Project Coordinator and plan to attend (in-person or remotely) monthly meetings with the Steering Committee throughout the course of the project. Consultant will be the lead facilitator for public meetings.

Public Outreach. Collecting input across a variety of neighborhoods and stakeholders for making a plan that is fair and equitable. A critical component of the Infrastructure Committee's support for this plan is their desire to collect input on safety and connectivity needs from a broad cross section of Town infrastructure users and compile that input into a user-friendly plan document.

- Consultant will work with the Steering Committee to conduct stakeholder interviews and or facilitate stakeholder discussions to engage a broad and representative segment of the population.
- The Steering Committee intends to survey individual neighborhoods and residents. Consultant will assist the Steering Committee to develop an online survey and marketing materials (poster/maps) to support their efforts conducting in-person outreach at neighborhood meetings and other events.
- The consultant will plan and facilitate 2-3 public meetings throughout this process, one of which will be a Selectboard meeting.

Connectivity Maps. The 2020 Downtown Master Plan identified several commonly traveled routes in Downtown in need of safety improvements for bicycles and pedestrians. This plan will contain sidewalk and/or connectivity maps showing the existing bike-ped network and future linkages for the Downtown area and the Town as a whole. These maps should be suitable for use in capital planning, the 2025 Town Plan Update, and in future grant and state-designated area applications.

Project matrix. This project will include a detachable matrix of current and future projects, ranging in size from crosswalk and safety improvements to more comprehensive corridor studies. The matrix will provide tracking details such as what phase of development each project is in and rough estimates of cost. During the planning process, this matrix will be customized according to the needs of the infrastructure committee for their use in capital planning.

Implementation recommendations. This project will identify 3-5 projects selected through the planning process, which emerged as priorities for future funding applications. As our budget allows, these projects will receive concept plans and cost estimates suitable for collecting public input and submitting grant applications. The consultant will also be encouraged to include suggested improvements that can be made to the capital planning process, such as examples from other towns.

Budget and Schedule-

This project will be completed using a \$19,900 Municipal Planning Grant from VT DHCD. The total project budget is \$24,000. We request completion of this project by the end of August.

This support may come in the form of a match, or a percentage contribution. We anticipate the study could be as much as \$20,000. We understand you are attempting to spread available dollars to a maximum number of communities and appreciate any and all support.
