- Call to Order: 6:32PM by Mike Audy.
- Approval of October 18, 2023 TAC Meeting Minutes. Moved by Jeff. Second by Norm. All in favor.
- <u>Traffic Safety Toolbox</u> Jim Sullivan, UVM. Jim shared a pdf of the toolbox. He has been presenting his work by going through the pdf. The toolbox is oriented to speeding counter measures particularly in transition zones between higher speed highways and village centers and downtowns. The tool box provides rough guidance for towns for countermeasures. It is not intended to guide regulations. VTrans has expressed a desire to be involved if measures are to be put in place. The document includes links for further resources. The document includes 15 single page fact sheets that profile speeding countermeasures, each linked from the table of contents. Maintenance concerns are addressed. The document also identifies measures that are discouraged or not allowed but are sometimes considered. There are three categories of countermeasures: horizontal deflections (7), vertical deflections (3), and perceptual/passive measures (5). Each measure is evaluated against eight criteria. Some measures couldn't be used on state highways, but could be applicable for town highways. Profile sheets include a description of the measure, pros and cons, an assessment of appropriate contexts, design considerations, and links to additional information. They found examples of all but one of the counter measures in Vermont, and local photos have been included. The document includes live links to the Google Street View image of where the measures have been
