

Panton Local Hazard Mitigation Plan Draft for Stakeholder Review

The Town of Panton has finalized a draft LHMP update that includes an update of Previous Hazard Mitigation Actions, a hazards inventory and risk assessment, and overall mitigation goals, and potential mitigation projects associated with the hazards identified. The plan will be submitted to the Vermont State Hazard Mitigation Officer for review and approval on January 15, 2024. Panton's Draft Local

Hazard Mitigation Plan (LHMP) for review can be found below.

Draft LHMP

A FEMA-approved LHMP is required for local governments that wish to receive federal funds from the FEMA Hazard Mitigation Grant Program (HMGP) and Building Resilient Infrastructure and Communities (BRIC) program. The LHMP is also one of the mitigation actions needed to qualify for additional post-disaster funding through the Emergency Relief and Assistance Fund (ERAF).

US Department of Energy Communities LEAP Program

The DOE Communities LEAP (Local Energy Action Program) aims to facilitate sustained community-wide economic and environmental benefits primarily through DOE's clean energy deployment work. This opportunity is specifically open low-income, energy-burdened to communities that are also experiencing either direct environmental justice impacts, or direct economic impacts from a shift away from historical reliance on fossil fuels.

Climate Economy Resilient Communities Program

VCRD's Resilient Communities Program supports three to five communities each year working on local climate action solutions that help reduce greenhouse gas emissions, lower energy use, increase climate resilience, and/or strengthen the local climate economy. Services are adaptable based on the community's needs and can include support with community engagement processes, strategic planning, technical assistance, and/or project implementation. Community leaders and volunteers submit a simple online application that will be reviewed on a rolling basis until January 12th, 2024.

Building Resilient Infrastructure & Communities (BRIC)

The Building Resilient Infrastructure and Communities (BRIC) grant program is an annual FEMA funding program for hazard mitigation. BRIC will support states, local communities, and territories, as they undertake hazard mitigation projects to reduce the risk from natural hazards.

Due: Jan 12, 2024



Flood Resilient Communities Fund (FRCF)

This is a voluntary program that will prioritize projects in communities and/or for homeowners with greatest economic need and projects that mitigate repetitive loss among low-income and marginalized portions of the population. **Applications are being accepted on a rolling basis**. Priority will be given to buyout projects following the July 2023 flooding in Vermont.

Vermont Better Roads Program

The Vermont Agency of Transportation is pleased to announce the 27th year of funding to support projects on municipal roads that improve water quality and result in maintenance cost savings. The grant funds are provided by the VT Agency of Transportation with partnership through the Vermont Agency of Natural Resources. The Vermont Better Roads Program promotes the use of erosion control and maintenance techniques that save money while protecting and enhancing water quality around the State.

VT Urban & Community Forestry Grant Programs

Communities Caring for Canopies

Projects must relate to urban and community forestry in public ways and places or at public educational institutions.

- \$70,000 available
- \$5,000 min, \$20,000 max award
- Projects must be completed by 10/31/2025

2024 Growing Urban Forests in the Face of Emerald Ash Borer

Projects must include one or more of the following. Removal of Ash trees located in public ways or places, tree planting in public ways or places in proximity to ash tree removals, and/or tree planting on private property, provided the municipality or applicant coordinates planting and approved permissions and agreements are in place.

• \$125,000 available



The VTrans has launched their Electrify Your Fleet program, offering organizations the opportunity to apply for up to twenty \$2,500 incentives. The Electrify Your Fleet program aims to transition from fossil-fueled transportation, addressing carbon emissions and promoting cleaner options. Priority is given to historically communities. Eligible underserved vehicles include electric, hybrid, bicycles, snowmobiles. motorcycles, and Participants must hold the vehicles for 24 months and demonstrate emission reduction. - Projects must be completed by 10/31/2025
- Eligibility: Projects must take place within 1 mile radius of designated areas through VT ACCD designation programs

2024 Urban & Community Forestry Grants

Projects should create and foster more resilient urban forests by increasing and maintaining a healthy urban tree canopy and access to nature. Projects must take place in or must directly serve at least one disadvantaged community.

- \$300,000 available
- \$5,000 min, \$50,000 max award
- NO COST-SHARE REQUIREMENT!
- Projects must be completed by 1/5/2026
