12:05 Winter Health Outlook- VT Department of Health

John Davy gave an update on COVID-19, flu and other respiratory diseases as we head into winter (see slides at https://acrpc.org/wp-content/uploads/2023/11/C19-ACRPC-presentation-20231108.pdf) COVID hospitalization cases have declined since 2022 and levelled off

A moderate wave is expected this winter (similar to 2020, but lower than 2021 & 2022)

Cold & Flu season is now called "Respiratory Disease Season (for COVID/Flu/RSV)

The upcoming season is expected to be lower than previous years, but with peaks of cases-It's unknown when peaks will happen, depends on immunization uptake

- There have been increases in RSV (Respiratory Syncytial Virus) in the southeast US- there's usually a couple months lag before it happens in the Northeast. However RSV season in Vermont is expected to be less severe
- Recent COVID variants have not been changing much (still a subset of Omicron- which the current vaccines are based on.)
- Influenza- Hillary Fannin reported that influenza-like illness is not above baseline activity in Vermont and introduced some surveillance tools.
