

ACRPC UPDATE

Municipal Energy Resilience Program (MERP) Update for Addison County Region

In total, over 600 buildings applied for free MERP Assessments. Addison Region towns have been approved for 47 building assessments to date, equaling about 10% of the State's approved assessments.

While a majority of Addison Region buildings are still waiting for assessments, BGS does have cost estimates based on progress across the State. Of the 47 assessments granted, 8 buildings have or will receive Level 1 assessments at an average cost of about \$3800. The remaining 39 buildings are granted

Level 2 assessments at an average cost of almost \$8,000.

In sum, the Addison County communities have received an estimated value of \$330,000 in free assessments.

These assessments qualify buildings for application to the \$500,000 MERP Implementation funds to complete the recommended energy retrofit projects. This program does not require matching funds and can be used as a match for other programs. Up to 20% of the granted implementation funds can be allocated to ADA accessibility projects in the building.

Finally, 16 of our 21 towns have applied for and received MERP Community Capacity grants of \$4000 for energy outreach and education. Applications for these \$4000 grants will remain open through 2024.

Otter Creek Basin Clean Water Service Provider (CWSP) Update

ACRPC serves as the Clean Water Service Provider (CWSP) for the Otter Creek Basin, an area that encompasses 936 square miles! The CWSP has been assigned a target phosphorus reduction allocation of 83 kg per each Formula Grant from DEC.

So far we've released three funding calls for proposals, and received 19 applications. Of these applications ten were for implementation projects, four were for design, three were for project identification and assessment, and two were for project development.

The Otter Creek CWSP is on track to meet the phosphorus reduction targets set forth in the initial Formula Grant. Implementation projects include five riparian plantings, a forestry project, a lakeshore restoration project, erosion control on a private road, and a dam removal. Collectively, these projects are anticipated to yield over 100 kg/yr of phosphorus removal, with just two projects accounting for more than 70% of that total.

After three rounds of funding we are developing a clearer picture of the world of potential projects, potential partners, and the scale of benefits possible.

Congratulations to 5 Addison County Towns Awarded Urban & Community Forestry Grants!

The Vermont Urban and Community Forest Program (VT UCF) recently announced the recipients of their 2024 grant season. In total, twenty-eight recipients will receive over \$710,000 in grant funding to support a wide variety of urban and community forestry stewardship projects across the state.

The towns of **Ferrisburgh** and **Panton** are 2 of 9 Vermont communities to receive funding through the VT UCF Communities Caring for Canopies program. This is VT UCF's traditional annual grant program and provides funding for a variety of activities to strategically move a local tree program forward.

Bristol, **Middlebury**, and **Vergennes** have all received Urban and Community Forestry grants. These grants are funded through an unprecedented one-time allocation from the Inflation Reduction Act of 2022, this category will support work to increase and maintain a healthy urban canopy and access to nature.

Electrify Your Fleet Program

The VTrans has launched their Electrify Your Fleet program, offering organizations the opportunity to apply for up to twenty \$2,500 incentives. The Electrify Your Fleet program aims to transition from fossil-fueled transportation, addressing carbon emissions and promoting cleaner options. **Priority** given to historically underserved communities. Emergency Management

Flood Resilient Communities Fund (FRCF)

This is a voluntary program that will prioritize projects in communities and/or for homeowners with greatest economic need and projects that mitigate repetitive loss among low-income and marginalized portions of the population. **Applications are being accepted on a rolling basis**. Priority will be given to buyout projects following the July 2023 flooding in Vermont.

Assistance to Firefighter (AFG) Grants

The AFG Program provides financial assistance directly to eligible fire departments, nonaffiliated emergency medical service (EMS) organizations, and State Fire Training Academies (SFTAs) for critical training and equipment.

The following equipment items for Fire Department and Regional Fire Department applicants are a High Priority:

• Appliance(s)/Nozzle(s)

- Basic Hand Tools (Structural/Wildland)
- Hose (Attack/Supply)
- Immediately Dangerous to Life or Health (IDLH) Monitoring Equipment
- IDLH Protection for Investigators (This is single-use respiratory protection)
- Personal Protective Equipment (PPE) Washer/Extractor/Dryer (Turnout)
- Rapid Intervention Team (RIT) Pack/Cylinder
- Thermal Imaging Camera (Must be NFPA 1801 compliant)
- Portable Radios (must be P-25 compliant)
- Vehicle Mounted Exhaust Systems
- Skid Unit
- Air Compressor/Fill Station/Cascade (fixed or mobile)

The grants can also cover replacement of damaged/unsafe/unrepairable PPE including Self-Contained Breathing Apparatus (SCBA) regardless of age. Micro grants are now up to \$75,000 and have the best/better chance to be approved.

Questions about Updating Your Local Hazard Mitigation Plan?

Local Hazard Mitigation Plans (LHMPs) form the foundation for a municipality's long-term strategy to reduce disaster losses and break the cycle of disaster damage, restoration, and repeated damage. Having an approved and current LHMP is often the final step for gaining a 12.5% state ERAF reimbursement rate (in addition to 75% of cost reimbursement from FEMA) as well as qualifying for many VEM and FEMA-funded hazard mitigation grants.

The state of Vermont annually applies for funding from the FEMA BRIC program and reaches out to Municipalities with soon-to-expire LHMP's. If the Municipality accepts the funding (it requires a 25% match of cash or time), they can hire a consultant that facilitates the creation or update of the LHMP and submits it to the state and FEMA for approval. LHMP's are valid for 5-years after FEMA approval.

The Nature Conservancy's Resilient and Connected Appalachians Grant Program

The Nature Conservancy's (TNC) Resilient and Connected Appalachians Grant Program (RCA) offers funding opportunities for non-profit organizations, municipalities, and other partners to engage in conservation efforts in the Appalachians—a center of climate resilience and a critical migration corridor for wildlife. The RCA offers grants of up to \$50,000 to support projects that result
