### Vermont Master Naturalist - Middlebury Area: Application for 2024-2025 Cohort

The Vermont Master Naturalist Program is now accepting applications for a 2024-2025 cohort in the Middlebury Area!

Vermont Master Naturalist (VMN) starts with a team of  $\sim$ 15 people passionate about natural history and willing to share knowledge of a related discipline. Staff and local experts then tell the story of the area's unique natural history in 5 field days, with each day building on the others. Topics may include geology, glacial history, wildlife ecology, human settlement history, botany, natural communities, and more, all emphasizing "reading" the landscape of the Champlain Valley and lower slopes of the Green Mountains. Participants then give back to the community by identifying and completing projects that fill community needs, often working in tandem with conservation commissions, land trusts, river conservancies, schools, and diverse other groups. The program costs \$600, with financial aid opportunities through VSAC and a limited VMN Scholarship Fund.

### **Important Reminders about Local ARPA Funds**

- It's that time again! The next required reporting for local ARPA funds is due by **April 30, 2024** for All ARPA expenditures from April 1, 2023 through March 31, 2024. Even if your municipality reported last year that all ARPA Funds were obligated and/or expended, you still must complete and submit the 2024 Project and Expenditure report.
- Now is also the time to think about obligating your local ARPA Funds if they haven't already been obligated. ALL LOCAL APRA FUNDS MUST BE OBLIGATED BY DECEMBER 31, 2024. This means placing an order for goods or services or entering into a contract, subaward, or similar transaction that requires payment. If your town is using ARPA funds to pay staff salaries or other internal costs, this needs to be documented with a resolution by the Selectboard.

# Community

#### **Better Places Grants**

Is your community thinking about expanding parks and green spaces, enhancing a lively main street, initiating public art projects, or establishing community gardens? If yes, consider applying for a Better Places Grant, supported by the VT Department of Housing & Community Development, VT Department of Health, and VT Community Foundation. This statewide grant program welcomes project submissions on a rolling basis.

### Rural Industry and Development Program

The Rural Industry and Development Program (RIDP) provides \$5,000,000 in grant funding to regional and local development corporations in areas that can accommodate business growth to increase the amount of move-in ready industrial space.

RIDP is designed to respond to a lack of available industrial space in areas that can accommodate business growth. RIDP provides grant funding through local development corporations to support business relocation and expansion efforts. Eligible uses include the purchase, demolition, building and/or renovation of property for industrial use.

#### **Electrify Your Fleet Program**

The VTrans has launched their Electrify Your Fleet offering program, organizations the opportunity to apply for up to twenty \$2,500 incentives. The Electrify Your Fleet program aims to transition fossil-fueled from transportation. addressing carbon emissions and promoting cleaner options. Priority is given to historically underserved communities. Eligible vehicles include electric, hybrid, bicycles, motorcycles, snowmobiles. and Participants must hold the vehicles for 24 demonstrate months and emission reduction. #### Weatherization Repayment Assistance Program (WRAP)

The Weatherization Repayment Assistance Program (WRAP) may be able to help you. WRAP is intended to assist both homeowners and renters in Vermont in pursuing home weatherization projects by allowing them to pay for the costs over time through a low-interest monthly charge on their utility bill.

WRAP assists with projects like insulation and air sealing a well as heat pumps,

# **Emergency Management**

#### Flood Resilient Communities Fund (FRCF)

This is a voluntary program that will prioritize projects in communities and/or for homeowners with greatest economic need and projects that mitigate repetitive loss among low-income and marginalized portions of the population. **Applications are being accepted on a rolling basis**. Priority will be given to buyout projects following the July 2023 flooding in Vermont.

#### **Questions about Updating Your Local Hazard Mitigation Plan?**

Local Hazard Mitigation Plans (LHMPs) form the foundation for a municipality's long-term strategy to reduce disaster losses and break the cycle of disaster damage, restoration, and repeated damage. Having an approved and current LHMP is often the final step for gaining a 12.5% state ERAF reimbursement rate (in addition to 75% of cost reimbursement from FEMA) as well as qualifying for many VEM and FEMA-funded hazard mitigation grants.

The state of Vermont annually applies for funding from the FEMA BRIC program and reaches out to Municipalities with soon-to-expire LHMP's. If the Municipality accepts the funding (it requires a 25% match of cash or time), they can hire a consultant that facilitates the creation or update of the LHMP and submits it to the state and FEMA for approval. LHMP's are valid for 5-years after FEMA approval.

# **Transportation**

### Safe Streets and Roads for All (SS4A) Grant Program

The SS4A program funds regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries. Over \$3 billion is still available for future funding rounds. The SS4A program provides funding for two types of grants: **Planning and Demonstration Grants** and **Implementation Grants**.

## **Natural Resources**

### Northern Border Regional Commission: Catalyst Program

The Catalyst Program is designed to stimulate economic growth and inspire partnerships that improve rural economic vitality across the Northern Border Regional Commission (NBRC) four state region (NY, VT, NH, ME).

NBRC encourages projects that take a creative approach to addressing an

provide Federal funds to develop, complete, or supplement an Action Plan. The goal of an Action Plan is to develop a holistic, well-defined strategy to prevent roadway fatalities and serious injuries in a locality, Tribal area, or region. Planning and Demonstration Grants also fund supplemental planning activities in support of an Action Plan and demonstration activities in support of an Action Plan.

**Implementation Grants** provide Federal funds to implement projects and strategies identified in an Action Plan to address a roadway safety problem. Eligible projects and strategies can be infrastructural, behavioral, and/or operational activities. Implementation Grants may also include supplemental planning and demonstration activities to inform an existing Action Plan, and project-level planning, design, and development activities. Applicants must have an eligible comprehensive safety action plan (referred to as an "Action Plan") to apply for an Implementation Grant.

The FY 2024 NOFO has multiple deadlines, depending on the grant type:

**April 4, 2024, 5 p.m. (EDT):** Deadline #1 for Planning and Demonstration Grants.

May 16, 2024, 5 p.m. (EDT): Sole deadline for Implementation Grants. Deadline #2 for Planning and Demonstration Grants.

August 29, 2024, 5 p.m. (EDT): Deadline #3 for Planning and Demonstration Grants. NOFO closes.
