

**ACRPC UPDATE** 

#### Flood Hazards and River Corridor Protection

May 8, 1-4pm at ACRPC office conference room (14 Seminary Street, Middlebury)

Following the regular quarterly meeting of the <u>Addison County Regional Emergency Management</u> <u>Committee</u> (12-1pm), ACRPC will host a workshop on flood hazards and River Corridor Protection at the conference room and via Zoom.

Flood Resilience Educator Sarah Noyes and Watershed Restoration Manager Shayne Jacquith from The Nature Conservancy will lead the workshop with a focus on river behavior, as well as risk reduction and co-benefits including wildlife habitat connectivity. Attendees will learn about the benefits of and process of working towards updated Town plan flood resilience chapters, increased zoning protections and benefits, at-risk property buyouts, and restoration of stream buffers and wetlands.

Members of the public and town officials including Planning Commissioners, Development Review Board members, Town Administrators and Managers, and Conservation Commissioners are invited, and members of the REMC are welcome to stay and attend. ## **Example 2.1** Basin 3 CWSP Call for Proposals for Clean Water Projects

As the Clean Water Service Provider (CWSP) for the Otter Creek Basin, ACRPC is Issuing a request for proposals for projects that improve water quality in Basin 3. Any proposed projects must be consistent with the Clean Water Initiative Program (CWIP) Funding Policy. Applicants must consult with DEC staff on potential project impacts on natural resources, like wetlands or river corridors and to give DEC 30 days to review project impacts.

Applications for this round of funding are due: June 12, 2024

#### **Addison County Towns Receive Grant Funding From VTrans**

Three towns in Addison County have received funding through VTrans Transportation Alternatives Program (TAP) and two have received funding through Municipal Highway and Stormwater Mitigation Program (MHSMP).

#### Congratulations to:

Bridport (MHSMP) - \$776,880 towards replacing a culvert on Middle Rd

**Shoreham (TAP) - \$531,532** towards the construction of a new box culvert on Doolittle Road.

Ferrisburgh (TAP) - \$500,000 towards the construction of multiple sidewalks along Route 7.

**Bristol (TAP) - \$240,000** towards the construction of a new ADA- accessible sidewalk along Airport Road.

Middlebury (MHSMP) - \$232,000 towards stormwater treatment on Adams Acres.

# **Municipal Energy Resilience Program (MERP) Community Capacity Building Mini-Grants Closing!**

The Mini-Grant application window is closing on May 31! If your municipality hasn't applied yet, we encourage you to do so right away.

This grant is non-competitive; any covered municipality (a city, town, incorporated village, fire district, or any other governmental incorporated unit except for school districts) who is applying for the first time will be awarded a Mini-Grant. The application is available on the BGS Mini-Grants page, where you can find community spotlights for inspiration on how to use your funds.

For municipalities that have received grant approval, it is important to return your signed agreement by June 30, 2024. Mini-Grants will be denied if agreements are not received by this date.

#### Help shape VELCO's 2024 Vermont Long-Range Transmission Plan

VELCO designs, builds, owns and operates the statewide transmission system and is responsible for Vermont's transmission grid reliability. The Plan identifies the new transmission line investments that may be needed to maintain system reliability.

This three-year update of VELCO's 20-year plan is part of a collaborative planning process established by Vermont's Public Utility Commission. VELCO's outreach is intended to gather public input on how best to address system reliability challenges using transmission lines and other solutions that best meet Vermont's broader energy needs.

## Community Heart & Soul Grant Program

The Community Heart & Soul Seed Grant Program is uniquely designed for small cities and towns (population 2,500-30,000). Successful applicants will receive \$10,000 grants to match funding from a participating municipality or a partnering organization. Awards are made on a **rolling basis**.

### Village Trust Initiative Has Launched!

Our villages are an essential part of Vermont's communities, identity, and future. The Village Trust Initiative (VTI) is designed to promote the community-driven revitalization of the physical and social infrastructure that have been the foundation of success for Vermont's small villages.

VTI is offered by the Preservation Trust of Vermont in partnership with the Vermont Council on Rural Development and the Vermont Community Foundation. The Initiative will offer expertise and funding to help 20 small Vermont towns create or bolster a local community trust organization and take on a transformational project in the village.

The Initiative's first year will support approximately seven communities. Selected communities will receive support with community engagement, predevelopment technical assistance and consulting/contracted services, and substantial implementation funding.

The selection process begins with the completion of a simple intake form due Friday May 24, 2024 by 4pm. A select number from the pool of interested communities, will be invited to submit a full application.

#### **Electrify Your Fleet Program**

The VTrans has launched their Electrify Your Fleet program, offering organizations the opportunity to apply for up to twenty \$2,500 incentives. The Electrify Your Fleet program aims to transition from fossil-fueled transportation, addressing carbon emissions and promoting cleaner options. Priority is given to historically underserved Eligible communities. vehicles include electric, hybrid, bicycles, motorcycles, and snowmobiles. Participants must hold the vehicles for 24 months and demonstrate emission reduction. Learn more here and apply here!

#### Weatherization Repayment Assistance Program (WRAP)

The Weatherization Repayment Assistance Program (WRAP) may be able to help you. WRAP is intended to assist both homeowners and renters in Vermont in pursuing home weatherization projects by allowing them to pay for the costs over time through a low-interest monthly charge on their utility bill.

WRAP assists with projects like insulation and air sealing a well as heat pumps, electric water heaters and advanced wood heating systems.

### **Emergency Management**

#### Hazard Mitigation Funding Following 2023 Summer Flooding

As a result of the catastrophic flooding of July 2023, there will be nearly \$90 million in federal Hazard Mitigation Grant Program (HMGP) funding available for Vermont communities. Importantly, the Administration and the State Legislature are working to allocate funding in the hopes that the State can cover the 25% non-federal cost share for hazard mitigation projects. Although VEM anticipates seeking additional time extensions from FEMA, the current deadline for submitting pre-applications is June 21

Eligible project types include:

- Buyouts
- Structural Elevations & Mitigation Reconstruction
- Natural resource projects such as floodplain restorations or dam removals
- Infrastructure projects such as upsizing bridges or culverts
- Floodproofing of municipal or commercial buildings
- Road relocation, elevation, or soil stabilization

#### **Rural Fire Protection Grant Program**

The installation of new dry hydrants and other types of rural water supplies is still the program priority, but eligible projects may include repair/upgrade, replacement, or relocation of existing rural water supplies (whether previously grant funded or not), and drafting site development. **Download the application packet here**.

#### Flood Resilient Communities Fund (FRCF)

This is a voluntary program that will prioritize projects in communities and/or for homeowners with greatest economic need and projects that mitigate repetitive loss among low-income and marginalized portions of the population. **Applications are being accepted on a rolling basis**. Priority will be given to buyout projects following the July 2023 flooding in Vermont.

# Safe Streets and Roads for All (SS4A) Grant Program

The SS4A program funds regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries. Over \$3 billion is still available for future funding rounds. The SS4A program provides funding for two types of grants: Planning and Demonstration Grants and Implementation Grants.

#### **Planning and Demonstration Grants**

provide Federal funds to develop, complete, or supplement an Action Plan. The goal of an Action Plan is to develop a holistic, well-defined strategy to prevent roadway fatalities and serious injuries in a locality, Tribal area, or region. Planning and Demonstration Grants also fund supplemental planning activities in support of an Action Plan and demonstration activities in support of an Action Plan.

**Implementation Grants** provide Federal funds to implement projects and strategies identified in an Action Plan to address a roadway safety problem. Eligible projects and strategies can be infrastructural,

#### VT Urban & Community Forestry - Community Tree Planting Grant Program

The Community Tree Planting Grant (CTPG) program goal is to support the planting of2,000 treesstatewide. The CTPG will hold two rounds of competitive grant applications to help fund tree planting projects in high priority areas across Vermont. These community projects will help increase urban tree canopy and improve water quality and public health by controlling stormwater.

Individual awards between \$5,000-\$75,000 will support tree planting to advance placemaking, climate resilience, and health equity in urban areas across the state.

Applications for the first round of funding due: May 17, 2024.

# Forestry Accelerator Now Accepting Applications

The Forestry Accelerator is a four month accelerator for North American start ups that are commercializing new and

behavioral, and/or operational activities. Implementation Grants may also include supplemental planning and demonstration activities to inform an existing Action Plan, and project-level planning, design, and development activities. Applicants must have an eligible comprehensive safety action plan (referred to as an "Action Plan") to apply for an Implementation Grant.

The FY 2024 NOFO has multiple deadlines, depending on the grant type:

May 16, 2024, 5 p.m. (EDT): Sole deadline for Implementation Grants. Deadline #2 for Planning and Demonstration Grants.

August 29, 2024, 5 p.m. (EDT): Deadline #3 for Planning and

Demonstration Grants. NOFO closes.
