

Changes to the 2025 Local Emergency Management Plan



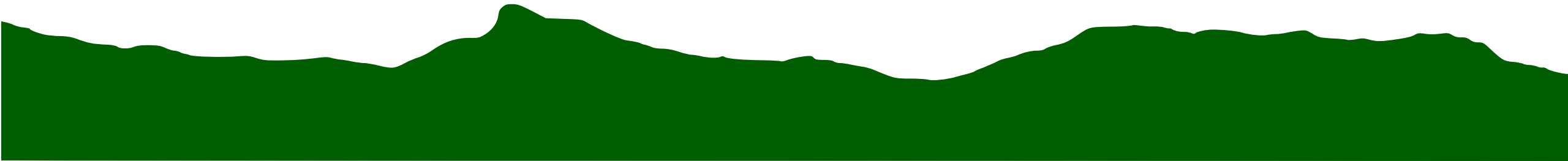
Background

- Created a sample LEMP and removed sample language from the template

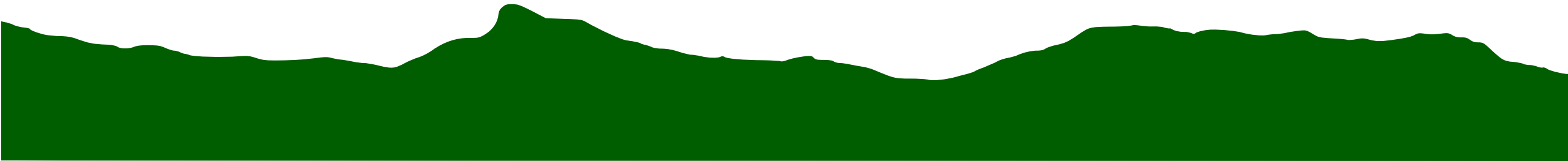


Municipal Adoption Form changes

- Added public contact method for EMD.
 - Added REMC representatives.
 - Noted that we share your contact information during life safety events, and added an "opt out" for sharing information with additional partners outside of an immediate life safety issue.
 - Municipal Adoption Form and Plan need to be submitted to your VEM Regional Coordinator, not Regional Planning Commission.
 - Submission deadline is now June 1, not May 1.

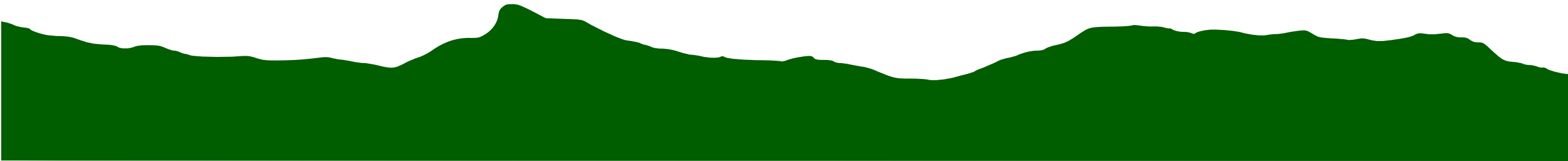
Plan requirement changes

- Emergency management planners
 - Must include EMD
- Municipal EOC
 - Added checklist of available resources
 - Clarified that address & phone number are required fields
- Resources
 - Added section for town or city owned resources
 - Reduced NIMS typed resource list from 58 to 8



Plan requirement changes

- Public information and warning
 - Clarified 3 public notice sites: 2 in town and 1 near town clerk's office
- Organizations and communities requiring additional coordination
 - Renamed to be more inclusive (previously vulnerable populations)
- Shelters
 - Regional shelter removed.
 - Added requirement that you must include a minimum of one shelter that your city or town has the authority to open.
- Contact information
 - Moved EOC staff to this section
 - Added neighboring EMDs
